Instructions

Determine Eligibility

Ensure you are eligible to enroll under the Tuition Exemption Program prior to filling out this application. For description of who is eligible please visit http://washington.edu/students/reg/tuition_exempt.html

Non-Matriculated Student Status

You need only apply for non-matriculated student status once as long as you maintain continuous enrollment in the same status. If you wish to change statuses, you will have to reapply to the appropriate status. If you take two quarters or more off consecutively, not counting Summer quarter, you will need to complete another Non-Matriculated Student Application. If you withdrew from a quarter, that counts as a quarter off from the university.

Deadlines

This application, and the proper Tuition Exemption Request form (which is due each quarter) must be submitted no later than 2 weeks, or 10 business days, prior to the first day of the quarter.

Directory Release Information

Generally speaking, FERPA (Federal Educational Rights and Privacy Act) allows the University to disclose directory information if the student has not placed a hold on it's release. Directory information is defined as: student name, address, email, phone, dates of birth and attendance, degrees received, major and minor fields of study, class, activities and sports, and most recent previous education institution attended.

If you do not want to appear in the Student Directory and do not want your Directory Information released, please check no in the box on the Application Form. You should be aware that restricting the release of your Directory information has consequences, for instance it may make it difficult or impossible for a potential employer to verify your enrollment or to verify you earned a degree from the University. Registering for Classes

After the Registration Office has received this application and your quarterly tuition exemption request form, you can register using the Registration option of the Personal Services on MyUW <http://myuw.washington.edu/>

Your student number and Private Access Code (PAC) will be mailed to you. If you already have a UW NetID, then you will keep the same one.
