TUITION REDUCTION FOR ACTIVE MILITARY PERSONNEL STATIONED IN WASHINGTON (INCLUDING DEPENDENTS)

ACTIVE DUTY PERSONNEL

ELIGIBILITY: You are eligible to pay resident tuition and fees if you are currently stationed in Washington State, on active duty, in the Army, Navy, Marine Corps, Air Force, or Coast Guard.

CONDITIONS: You will be classified to receive in-state tuition; however, you will not be eligible to receive financial aid benefits that are only available for students who satisfy the statutory requirements regarding Washington State residency for tuition purposes.

PROCEDURES: Complete the application section and attach a copy of your military orders showing the date of your assignment to Washington State and a copy of your military identification card (front side only).

DEPENDENTS

ELIGIBILITY: You are eligible to pay resident tuition and fees if you are the spouse or child of an active duty service member stationed in Washington State.

CONDITIONS: You will be classified to receive in-state tuition; however, you will not be eligible to receive financial aid benefits that are only available for students who satisfy the statutory requirements regarding Washington State residency for tuition purposes.

PROCEDURES: Complete the application section and attach a copy of your sponsor's military orders showing the date of assignment to active duty service in Washington State and a copy of your military identification card verifying your dependent status (front side only).
