



TUITION REDUCTION FOR WASHINGTON NATIONAL GUARD MEMBERS (INCLUDING DEPENDENTS)

WASHINGTON NATIONAL GUARD MEMBER

ELIGIBILITY: You are eligible to pay resident tuition and fees if you are a member of the Washington National Guard.

CONDITIONS: You will be classified to receive in-state tuition as long as you remain a member of the Washington National Guard; however, you will not be eligible to receive financial aid benefits that are only available for students who satisfy the statutory requirements regarding Washington State residency for tuition purposes.

PROCEDURES: Complete the application section and attach a Statement of Service and a copy of your military identification card (front side only).

DEPENDENTS

ELIGIBILITY: You are eligible to pay resident tuition and fees if you reside in the state of Washington and are the spouse or dependent of a Washington National Guard member.

CONDITIONS: You will be classified to receive in-state tuition as long as they remain a member of the Washington National Guard; however, you will not be eligible to receive financial aid benefits that are only available for students who satisfy the statutory requirements regarding Washington State residency for tuition purposes.

PROCEDURES: Complete the application section and attach a Statement of Service confirming your sponsor's Washington National Guard service and a copy of your military identification card verifying your dependent status (front side only).
